Medicare Supplement insurance policies renew automatically, subject to our right to change the premiums,* including an increase when you attain the next higher age bracket (as outlined in the above chart) or if we raise the premium for all policies like yours in the state. Changes to your premium will apply on your policy anniversary date. Premiums may be paid on a monthly, quarterly, semi-annual or annual basis.

The smoker premium factor does not apply to applicants during their open enrollment period.

The term of coverage will be for one month, three months, six months or twelve months depending upon the payment option selected.

*Aetna Individual Supplement Plan policyholders will receive notice of any premium changes 31 days before changes become effective. Medicare Part A and Part B coinsurance, deductible and/or coverage changes are generally announced in October to take effect the first day of the following January. Aetna will provide notification of any Medicare changes as soon as possible after those changes are announced.
